READING, MASTER OF EDUCATION (M.ED.) WITH A CONCENTRATION IN TEACHING ENGLISH TO SPEAKERS OF OTHER LANGUAGES

Program goal

The M.Ed. in Reading with a concentration in teaching English to speakers of other languages is a 33-credit-hour program that prepares individuals for a broad range of positions related to the education of multilingual learners/English learners. Students will learn about different methods and strategies for working with students who are in the process of developing English as an additional language.

Students are encouraged to take LING 390/ENGL 390/ANTH 390 and six credit hours of foreign language before enrolling in the program. Students who pursue this concentration will **not** be endorsed as a K-12 reading specialist. Students who already have initial licensure and are interested in pursuing an endorsement as a Reading Specialist K-12 in Virginia must take the following nine credit hours in addition to the curriculum listed below: READ 600, READ 605 and READ 700.
